# PIEDMONT SPRING PLANT & FLOWER SALE VENDOR APPLICATION

## APRIL 29 – MAY 2, 2021

THURSDAY / FRIDAY / SATURDAY: 8 AM – 6 PM | SUNDAY: 10 AM – 4 PM

Booth fees for the four-day event are \$325.00 per space (NON-REFUNDABLE). **Payment must accompany a completed application. Please make checks payable to the SC Department of Agriculture and mail to the attention of Ardonia Summerall, 1354 Rutherford Road, Greenville, SC 29609. A \$50.00 late fee will be applied to applications postmarked after the March 19, 2021 deadline.** Applications and checks will be returned once all available spaces are filled. First time vendors must include a picture of booth set-up to be considered. Spaces are approximately 10'x 20' inside and 20' x 20' outside. Tables may be rented for a charge

of \$10.00 each at the time of application. Space assignments will be given at set-up on Wednesday, April 28, from 10 a.m. – 5 p.m. **All vendors must be off of the premises by 6 p.m. on the day of set-up.** Takedown is permitted after 4 p.m. on Sunday, May 2 and not before. Vendor responsibilities include but are not limited to: business licenses, insurance, taxes, and personal requirements including; hoses, chairs, duct tape, electrical cords, tables, signs, etc. **Pets are not allowed. Overnight RV's or campers cannot be accommodated on market property. SCDA is not responsible for lost or damaged products.**
