PEE DEE SPRING PLANT & FLOWER FESTIVAL VENDOR APPLICATION

APRIL 20 – 23, 2023

THURSDAY / FRIDAY / SATURDAY: 8 AM – 6 PM | SUNDAY: 10 AM – 4 PM

Booth fees for the four-day event are \$325.00 per space (NON-REFUNDABLE). **Payment must accompany a completed application. Please make checks payable to the SC Department of Agriculture and mail to the Pee Dee State Farmers Market, 2513 W. Lucas Street, Florence, SC 29501. A \$50.00 late fee will be applied to applications postmarked after the March 29, 2023 deadline.** Applications and checks will be returned once all available spaces are filled. First time vendors must include a picture of booth set-up to be considered. Spaces are approximately 14' x 14' under roof in the drive-thru market and 20' x 30' outside. Tables may be

rented for a charge of \$10.00 each at the time of application. Space assignments will be given at set-up on Wednesday, April 19, from 7 am – 5 pm. All vendors must be off the premises by 6 pm on the day of set-up. Takedown is permitted after 4 pm on Sunday, April 23 and not before. Vendor responsibilities include but are not limited to: state sales tax license, insurance, taxes, and personal requirements including; hoses, chairs, duct tape, electrical cords, tables, signs, etc. **Pets are not allowed. Overnight RV's or campers cannot be accommodated on market property. SCDA is not responsible for lost or damaged products.**
