Fee for the one-day event is \$30 per space to set up on Saturday morning starting at 7 am OR \$25 per space to set up on Friday evening from 5-7 pm. **All set up must be completed by 10 am Saturday**, the advertised start time of the event. To be eligible to participate, **this application must be received no later than Friday March 17<sup>th</sup> with payment by cash or check\***. Make checks payable to Pee Dee State Farmers Market. **All 14'x14' spaces are inside the market and under the roof.** 8' banquet tables and electric power are available for rent, if needed, and must be requested at the time

of this application. (See below) Takedown is only permitted after 5 pm on Saturday, March 25. Tents and any promotional material can be used, provided they fit within the space allocated. Vendor responsibilities include but are not limited to removal of all trash and refuse, state sales tax license, and insurance. Advertising for the event is done by SCDA's Marketing Department on social media and will include an incentive for a food purchase (see flyer for details). *(\*Event fees will be refunded in full for applications not accepted due to space OR duplication of product lines.)*
