# MIDLANDS SPRING PLANT & FLOWER FESTIVAL VENDOR APPLICATION

Booth fees for the four-day event are \$325.00 per space (NON-REFUNDABLE). **Payment must accompany a completed application. Please make checks payable to the SC Department of Agriculture and mail to the attention of SC State Farmers Market, 208-A Wholesale Lane, West Columbia, SC 29172. A \$50.00 late fee will be applied to applications postmarked after the March 21, 2024 deadline.** Applications and checks will be returned once all available spaces are filled. First time vendors must include a picture of booth set-up to be considered. Spaces are approximately 12'x24'

each. Space assignments will be given at set-up on Wednesday, April 10, from 9 am – 5 pm. **All vendors must be off of the premises by 8 pm on the day of set-up.** Takedown is permitted after 5 pm on Sunday, April 14, and not before. Vendor responsibilities include but are not limited to: state sales tax license, insurance, taxes, and personal requirements including; hoses, chairs, duct tape, electrical cords, tables, signs, etc. **Pets are not allowed. Overnight RV's or campers cannot be accommodated on market property. SCDA is not responsible for lost or damaged products.**
