# **CLEMSON AG SERVICE LAB PROMOTES GAME-**WINNING TURF FOR ATHLETIC PROGRAMS

It's spring and sports talk turns to baseball, softball and golf. But before a bat cracks or a club swings, Clemson University Agricultural Service Laboratory staff help prepare the fields and courses for play.

Shannon Alford, lab director, said soil samples for all campus athletic fields and golf

courses are analyzed each January. Clemson Athletic Grounds and Fields staff use this information to maintain these surfaces. Bermudagrass is grown on all Clemson University sports fields.

"We conduct standard soil tests to determine mineral and pH levels," Alford said. "The reports generated from these tests show what nutrients need to be applied to the soil so that the turf can remain healthy throughout the season."

Soil tests can be used as a management tool to help in decisions related to fertilizer and limestone applications for commercially grown crops, home gardens, fruit trees, ornamentals, lawns, as well as athletic fields and fairways.

Each soil test provides a scientific basis for maintaining optimum soil fertility levels and proper soil pH values. Soil testing also protects against environmental hazards resulting from excessive fertilizer applications.

Crop codes are used for recommendations based on what is determined from each soil test. Separate Bell and his team start preparing the baseball and softball fields each October when they overseed with ryegrass. Bermudagrass is a warm-season grass that goes dormant and turns brown after the first frost. Dormant bermudagrass does not provide an aesthetically pleasing playing surface.

Ryegrass provides a cover for bermudagrass to prevent damage from harsh winter weather. Overseeded bermudagrass allows for a better appearance and play, as well as better turfgrass quality. Appearance is important.

"Television is an important part of the sports industry," said Lambert "Bert" McCarty, Clemson professor emeritus of turfgrass science and management. "Images viewers see on the field or course and on their television screens require the turf to be aesthetically pleasing."

McCarty and Grady Miller at North Carolina State in Raleigh have written a playbook for managing sports fields. Best Management Practices for Carolina Sports Fields contains research-based information and serves as a reference guide for sports field managers, students and regulatory agencies worldwide.



ll across the state of South Carolina, trees are in bloom and farmers are out preparing fields and planting crops. Oh yeah, and the pollen is back and everything's got a hint of yellah!

This is the time of year everyone gets excited about Certified South Carolina produce. But we have a long way to go until we're safe from frost.

In this issue of Market Bulletin you'll see our first of two listings of Certified SC Grown strawberry farms and U-pick operations. By the time this issue is published, a good number of fields will already be open for U-pick, with most of the rest targeting end of March/early April. I can remember when it was mid April before we saw any strawberries.

However, the recent rainfall is a factor. **Extension** agents are reporting that rainy weather has many fields very soggy. Wet weather also can cause concerns about disease and pests. And, of course, throughout March and April there's always the threat of a freeze. Strawberry growers usually protect their rows from frost by pulling row covers over them, but some other growers have a tougher time. Peach trees are blooming across the state. They're a lot harder to frost protect, though some growers do manage it.

frost damage. If the temperature dips, you'll see farmers frost-protecting them with spray irrigation to encase them in ice for insulation.

On the vegetable side, asparagus season is right around the corner. According to the new Census of Agriculture, asparagus is the cool thing to grow here lately - acreage in the state increased from 12 acres in 2012 to 482 acres in 2022. Of course, South Carolina was once the asparagus capital of the US.

Farmers are picking onions, leafy greens, herbs and root vegetables. Visit a farmers market or roadside stand, or look for the Certified SC label at the grocery store, and support our farmers while enjoying some spring produce.

On the row crop side of the aisle, things are



codes are provided for athletic fields and crops.

"These codes have developed over time," Alford said. "We are able to give specific recommendations based on what is being grown."

> K.C. Bell, Clemson University director of grounds, said soil tests are necessary so that his team will "know where to start for spring." One part of the soil test that gets special attention is the pH level, or level of acid, in the soil. The ideal pH level is 7.

> "We need to know if the pH is correct or if we need to add lime," Bell said. "If the pH level is off, people can put whatever they want to on their plants, but the plants still won't grow."

In addition to sports fields, the Clemson Agricultural Service Laboratory also conducts soil testing for lawns, crops, ponds and more. Information about how to collect soil samples, submit soil samples and understand soil test reports is available in the Clemson Home and Garden Information Center (HGIC) Soil Testing Fact Sheet 1652.

Once clients receive reports from their soil tests, they can call the staff at the Clemson Home and Garden Information Center, (888) 656-9988, or their local Cooperative Extension Service county office for consultation.

Other tests provided from the Clemson Agricultural Service Laboratory include tests for feed and forages, plant tissue, irrigation water, animal waste and compost.

# USDA FINALIZES VOLUNTARY "PRODUCT OF USA" LABEL CLAIM TO ENHANCE CONSUMER PROTECTION

Phoenix, Ariz., March 11, 2024 – Today, at the National Farmers Union Annual Convention, U.S. Department of Agriculture (USDA) Secretary Tom Vilsack announced the finalization of a rule to align the voluntary "Product of USA" label claim with consumer understanding of what the claim means.

Secretary Vilsack also announced USDA is awarding \$9.5 million to 42 projects through the Local Meat Capacity grant program to expand processing options for the meat and poultry industry and new actions to ensure transparency and a fair and competitive market in the U.S seed industry.

"Today's announcement is a vital step toward consumer protection and builds on the Biden-Harris Administration's work to bolster trust and fairness in the marketplace where smaller processors can compete," said Agriculture Secretary Tom Vilsack. "This final rule will ensure that when consumers see 'Product of USA' they can trust the authenticity of that label and know that every step involved, from birth to processing, was done here in America."

"In addition, the Local Meat Capacity grants are addressing critical processing infrastructure needs for local and regional livestock and poultry producers, ensuring their products get to market efficiently and cost effectively, which supports local economies, new jobs, and more choices for consumers," Secretary Vilsack added. "USDA is also committed to boosting the farmer's voice in our seed patent system and enforcing the disclosure laws on the books as we deliver more and better choices for farmers."

# BY USDA

These actions build on President Biden's Executive Order on Promoting Competition in the American Economy and the Biden-Harris Administration's Action Plan for a Fairer, More Competitive, and More Resilient Meat and Poultry Supply Chain. They complement a series of other all-encompassing actions by USDA to increase competition in agricultural markets, create a fairer playing field for small- and mid-size farmers, lower grocery costs for consumers, and strengthen local and regional food systems.

# "PRODUCT OF USA" FINAL RULE

USDA's final "Product of USA" rule allows the voluntary "Product of USA" or "Made in the USA" label claim to be used on meat, poultry and egg products only when they are derived from animals born, raised, slaughtered and processed in the United States. The rule will prohibit misleading U.S. origin labeling in the market, and help ensure that the information that consumers receive about where their food comes from is truthful.

USDA's final "Product of USA" rule is supported by petitions, thousands of comments from stakeholders, and data from a nationwide consumer survey.

Under the final rule, the "Product of USA" or "Made in the USA" label claim will continue to be voluntary. It will also remain eligible for generic label approval, meaning it would not need to be pre-approved by USDA's Food Safety and Inspection Service (FSIS) before it can be used on regulated product, but would require the establishment to maintain documentation on file to support the claim. The final rule also allows the use of other voluntary U.S. origin claims on meat, poultry and egg products sold in the marketplace. These claims will need to include a description on the package of the preparation and processing steps that occurred in the United States upon which the claim is made.

USDA has also published an updated labeling guidance on the use of voluntary U.S.-origin label claims to provide examples of claims and the types of documentation that establishments may maintain to support use of the claims. The guidance will be open for public comment for 60 days after publishing in the Federal Register. Public comments can be submitted at regulations.gov.

Establishments voluntarily using a claim subject to the final rule will need to comply with the new regulatory requirements by January 1, 2026, and are encouraged to do so as soon as practicable after the publication of this final rule.

USDA is also awarding \$9.5 million to 42 projects through the Local Meat Capacity (Local MCap) grant program. This initial set of awards through Local MCap is for Simplified Equipment Only projects.

# **AG + ART TOUR BOUND FOR MORE S.C. COUNTIES THAN EVER**

NINE COUNTIES JOIN LINEUP FOR NATION'S LARGEST FREE FARM TOUR IN 2024

CLEMSON, S.C. - Clemson Cooperative Extension's Ag + Art Tour was already the nation's largest free farm tour, with more than 100,000 visitors since it began, and this year's tour will showcase the state's cultural heritage and hard-working farmers to more South Carolinians than ever.

Recognized by the South Carolina House of Representatives last year as a "national example" of a program that champions agritourism, the 2024 South Carolina Ag + Art Tour has added nine new counties to 11 that have previously participated to feature over 150 tour sites statewide.

Clemson Extension Agribusiness Agent Will Culler, the tour's director, said the free self-guided farm and art tour is a way to educate people about where their food and fiber come from and introduce them to local artisans, while also supporting the state's agribusiness industry.

"We are proud of the commitment of our farms, artisans and county teams. Because of that, we can sustain continued growth," Culler said. "One of our goals has been to give people a better knowledge of what is produced in their backyard and help them to support local businesses while making healthier food choices. This event does that by putting food and product with a face."

Since it began in York County in 2012, the tour has added at least one new county each year, and South Carolina Commissioner of Agriculture Hugh Weathers has called it a tribute to "the beauties of agritourism."

"Blending in the art component, I just think that's fascinating. The variety of opportunities that families have now to do that and the way it's grown with the number of counties involved is a clear example of how a collaborative effort gets the results it receives," Weathers said.

Tour stops include farms and farmers' markets, and artisans on the tour range from weavers, painters, storytellers, metalworkers, and craftspeople to poets and live musical performances.

Some farms offer value-added products, such as jarred and canned foods, honey, baked goods or even farm-fresh meals. There is no fee to attend; visitors can start and stop their tour at any location.

# SOUTH CAROLINA FESCUE FARMERS NEEDED FOR CLIMATE-SMART AGRICULTURE STUDY

BLACKVILLE, S.C. - As United States farmers look for ways to improve productivity amid a changing climate, land-grant university researchers are joining forces to help grassland farmers enter the emerging carbon economy while enhancing yields and ecological benefits.

The researchers are engaged in a study focusing on forage systems in the Tall Fescue Belt. This region represents the core of fescue grassland agriculture in the southeastern United States.

Liliane Silva, assistant professor and Cooperative Extension Service livestock and forages specialist at the Edisto Research and Education Center (REC), is leading the charge for Clemson University.

"The goal of this project is to equip and empower grassland farmers to enter the carbon economy while enhancing operation resiliency and optimizing profitability, soil health and biodiversity," she said.

Carbon markets are trading systems in which carbon credits are bought and sold. Several markets have emerged in the United States.

"Even modest changes in management practices can have a tremendous impact on soil carbon, greenhouse gas emissions and associated economic implications for producers," Silva said.



Installation and maintenance guidelines will be provided for each practice. Silva will collect data from participating farms to determine carbon accumulation and other responses to the practices implemented.

This study is funded by a \$30 million grant from the United States Department of Agriculture's Partnerships for Climate-Smart Commodities. In addition to Clemson University, other land-grant partners include the University of Arkansas, Alabama Cooperative Extension, University of Kentucky, University of Missouri, North Carolina State University, Purdue University University of Tennessee, Tennessee State University, Virginia State University and Virginia Tech University.

Silva is looking for South Carolina farmers with grazing livestock for the study. Participating farms will be compensated. Farmers can start enrolling in the program in March.

Grasslands are the single largest agricultural land use in the United States and agriculture's largest and most effective carbon-storage system. These lands also offer opportunities to make a strong, positive impact on agriculture across the region and foster engagement in emerging carbon markets. Liliane Silva, Clemson Extension forages specialist, is working with land-grant researchers to help grassland farmers enter the emerging carbon economy while enhancing yields and ecological benefits.

The study involves implementing management practices such as establishing native warm-season grasses, using prescribed burn, interseeding legumes as an alternative nitrogen source, improving grazing management and establishing a perennial pollinator buffer on participating farms in the fall. Other management practices used in the study include silvopasturing and amending soil with biochar or gypsum.

Corporate partners for this study are Tyson Foods, Inc., JBS Foods, Corteva, Farm Credit Mid-America, Ecosystem Services Marketing Consortium, American Forage and Grassland Council and the National Grazing Lands Coalition.

Also partnering in the project are the National Cattlemen's Beef Association, the United States Roundtable for Sustainable Beef, multiple state cattle associations, American and Tennessee Farm Bureau Federations, The Nature Conservancy, American Bird Conservancy, Monarch Joint Venture, National Bobwhite Conservation Initiative, Tennessee Department of Agriculture, Missouri Department of Conservation and Virginia Department of Conservation and Recreation.
