<u>Civil Penalty</u>: \$1,000.00 <u>Permit Number</u>: 23-206-12029 <u>Summary</u>: The Department conducted inspections on August 21, 2023, and July 22, 2024. The Individual/Entity has violated the South Carolina Retail Food Establishment Regulation as follows: failed to ensure that time/temperature control for safety foods was maintained at a temperature of 41 degrees F and below or 135 degrees F and above, except during preparation, cooking, or cooling; and failed to ensure that refrigerated, ready-to-eat, time/temperature control for safety foods were discarded if the temperature and time combination exceeded seven (7) days or if the package was not properly date marked.

<u>Previous Orders</u>: The consent order (23-350-FOOD) was issued when the Individual/Entity violated the South Carolina Retail Food Establishment Regulation by failing to ensure that refrigerated, ready-to-eat, time/temperature control for safety foods were discarded if the temperature and time combination exceeded seven (7) days or if the package was not properly date marked; and by failing to ensure there was no bare hand contact with ready-to-eat foods.
