### SOUTH CAROLINA ANNOUNCES FARM AND FOREST AID FOR HELENE RELIEF

COLUMBIA - The South Carolina Department of Agriculture will use federal funding to issue \$38 million in targeted aid to South Carolina farmers and forest landowners who sustained certain losses and damage from Hurricane Helene in 2024.

The South Carolina Disaster Relief Block Grant for Helene, which

will roll out later this year, is aimed at production losses not covered by other USDA programs or crop insurance. The program will cover four categories of eligible losses: infrastructure damage, market losses, future economic losses, and timber losses. It will apply to the 33 counties and one tribal area that received a Presidential Disaster Declaration for Hurricane Helene.

"South Carolina's farmers and forest landowners have worked tirelessly to recover from Helene's devastation, and this funding will close crucial gaps to assure a future for their businesses," said South Carolina Commissioner of Agriculture Hugh Weathers. "A strong agriculture and forestry sector is essential to our state's economy and security, and we're committed to distributing this funding quickly. I'd like to thank South Carolina's farmers and forest landowners who offered information and feedback, and US Secretary of Agriculture Brooke Rollins and her staff for their collaboration as we work to get this critical aid into the right


"This USDA block grant is a game-changer," said State Forester Scott Phillips. "For the first time in



hurricane will receive financial assistance to help Unlike row crops, timber isn't typically insured, leaving landowners with few options beyond the partners at the South Carolina Department of Agriculture and USDA for recognizing the need and working together to bring this long-overdue support to our state's forestry community."

To receive funding, certain producers must agree to acquire and maintain USDA Risk Management coverage for a period of two crop years for market loss, future economic loss, plasticulture, and aquaculture claims. Applicants will have to supply documentation of losses, among other requirements, and agriculture producers will be required to provide a USDA Farm Service Agency number.

SCDA is currently creating the program work plan and application in coordination with USDA. As more information about the program is available, it will be posted at agriculture.sc.gov/helene. The page also has a signup link to receive email alerts about the program.





### **RELIEF ON THE HORIZON**

or months, our 🕯 agency has been working with USDA on a program to bring relief to some farmers and timber owners still struggling in the aftermath of 2024's Hurricane Helene. On Sept. 30, we were proud to announce a state-run block grant to address some outstanding needs. While crop insurance and other federal relief programs have covered some of the losses from that major storm a year ago, there are still some gaps that I look forward to helping fill.

As I write this column, the federal government is shut down, but that doesn't mean work on the grant has stopped. At the South Carolina Department of Agriculture, we are in the midst of developing a detailed workplan for the grant in cooperation with the South Carolina Forestry Commission. Our workplan will guide our rollout of the application and our outreach efforts. It will have to approved by the USDA, so they need to get back into the office.

We expect to open applications for the grant around the end of the year, but the shutdown could change that.

Please visit agriculture. sc.gov/helene to read more about the grant and who will qualify, as well as what you can do now to prepare. You can also

sign up at that website to receive email updates about the grant so you don't miss trainings and the application period.

Take a look, and stay in touch. We may not be able to answer all your questions now, but we'll work to get you an answer.

With USDA shut down, we are without some of the reporting we normally rely on. Anecdotally, harvest has been proceeding well across South Carolina. The dry weather made the early peanut harvest a little difficult, as the dry dirt didn't want to let go during digging. However, that situation has gotten better with some rain the first week of October.

Cotton is looking gorgeous across our state right now. I love seeing those white fields. It's one of the reasons I love taking the backroads when I can.

Some soybeans are looking good, but late varieties might be impacted by the dry spell in September.

We are thankful for the international markets that are buying South Carolina soybeans right now, and hopeful for trade deals that will bring other partners back to the table. We'll continue working with the port, and with our partners around the state and country, to develop some more ways to move those beans.

# CLEMSON'S PEELER COLLEGE OF VETERINARY MEDICINE

CLEMSON, S.C. — The Harvey S. Peeler Jr. College of Veterinary Medicine (PCVM) is moving steadily toward welcoming its first class in fall 2026, pending accreditation. While details continue to take shape, the college is committed to preparing future veterinarians to serve South Carolina and beyond. Below are important updates for prospective students, families, and stakeholders as we prepare for this historic launch.

The college is awaiting accreditation approval from the American Veterinary Medical Association (AVMA). The PCVM will notify students and stakeholders as soon as the Letter of Reasonable Assurance is received and the application window is open.

For the inaugural Class of 2030, the PCVM will use an independent application that will be posted on the homepage, student page and LinkTree. Beginning in January 2026, applicants for admission in 2027 (Class of 2031) will apply through the Veterinary Medical College Application Service (VMCAS).

The program will prioritize South Carolina residents, with 60 of the 80 inaugural seats reserved for in-state students. Residency is determined by permanent address, not current college or university enrollment. Twenty seats will be available to at-large students from outside the state.

While South Carolina has a particular need for large animal veterinarians, the PCVM will admit students interested in all areas of veterinary medicine.

Construction of the new veterinary medicine campus remains on track. Facilities are scheduled to be ready to welcome students in fall 2026, pending accreditation approval.

Clemson hopes to provide partial scholarship support for all 60 in-state students.

Applicants meeting minimum requirements will receive an asynchronous interview link with instructions for recording and submitting their responses.

# TWO-SPOTTED LEAFHOPPER THREATENS SC OKRA CROPS

South Carolina okra growers are facing an unexpected challenge this season: a significant infestation of the two-spotted leafhopper.

The outbreak has affected farms across eastern counties, resulting in yellowing leaves, reduced yields and, in some cases, complete crop loss.

Zack Snipes, a Clemson Cooperative Extension Service area horticulture agent, noted that while okra is typically resilient against pests, this year's infestation has been "uniquely different."

"The insect has also been spotted on eggplant and sunflower crops, though the damage there has been less severe," Snipes said.

Also referred to as the "cotton jassid," the insect migrated north from Florida, where it was initially detected in the U.S. It affects multiple crops, including cotton, okra, sunflowers, eggplants, and others.

Chris Sumter, a seasoned okra grower from Sumter County, shares his firsthand experience.

"This is the first time I've seen anything like this," he said. "We're learning in real-time how to detect and control this insect."

Sumter, who has grown okra for more than a decade, is preparing transplants for next season. He is considering greenhouse cultivation to protect young plants.

"I also plan to physically space plantings," Sumter said. "I believe this may help slow the spread of the pest."

Growers and Extension agents are currently using Beleaf, a Group 29 insecticide labeled for vegetables and effective against sucking and piercing insects.

However, concerns about resistance have prompted discussions about rotational partners and the active ingredients in Group 29 insecticides — a category of selective feeding blockers classified by the Insecticide Resistance Action Committee (IRAC). These insecticides prevent certain insects, particularly phloem-feeding ones like aphids and whiteflies, from feeding on plants.

Charleston County leads the state in okra production, followed by smaller operations in Sumter. As the season progresses, Clemson Extension experts are working closely with growers to gather data, monitor pest activity, and explore management strategies.

Sumter is interested in using both chemical and holistic pest management strategies.

"This is where land-grant university research becomes critical," Sumter said. "We need to understand this insect better to help us prepare for next year. Clemson provides the research, and Extension agents share this research with growers."

The two-spotted leafhopper is a small, pale green insect with transparent wings that have a distinctive black spot near the tip of each forewing. Both adults and nymphs feed on plant leaves. The main symptom of okra is hopperburn, characterized by yellowing, reddening and eventually browning of the leaves, especially along the veins.

Affected leaves may also curl and eventually fall off, leading to reduced growth and yield.

Figures from 2024 show that okra was grown in 25 counties with an estimated value of \$2,417,040 in South Carolina. For more information on okra production and pest management strategies, visit Clemson Farmgate Reports.



### SOUTHEASTERN U.S. SCIENTISTS LAUNCH CALENDAR TO HELP MANAGE SPOTTED LANTERNFLY

Now that the invasive spotted lanternfly (SLF) has been detected in South Carolina, Clemson University is offering a tool to help ornamental growers detect and manage this pest early.

The seasonal spotted lanternfly management calendar was developed by a team of entomologists from leading Southeastern U.S. universities.

This initiative is led by Zee Ahmed stationed at the Clemson University Pee Dee Research and Education Center, in collaboration with Shimat Joseph of the University of Georgia, Midhula Gireesh of the University of Tennessee, Karla Addesso of Tennessee State University and Alejandro Del Pozo-Valdivia of Virginia Tech.

"This calendar is a proactive tool designed to guide growers through the seasonal stages of SLF activity," Ahmed said. "By aligning management strategies with the pest's life cycle, we can improve early detection and reduce the impact on ornamental crops."

The calendar outlines key monitoring and control actions, offering practical, science-based recommendations tailored to the southeastern climate and growing conditions. It emphasizes early identification, targeted pesticide applications and cultural practices to limit SLF spread.

The spotted lanternfly was spotted on July 10th, 2025. This insect poses a significant threat to agriculture and horticulture, feeding on a variety of plants including grapes, fruit trees and ornamentals. Its presence can lead to reduced crop yields, plant stress and economic losses for growers.

Anyone who believes they may have seen a spotted lanternfly is asked to report this to Clemson University Regulatory Services.

As with many invasive insects and plant diseases, this species arrived in the U.S. from overseas. It continues to spread throughout the country by hitching rides on vehicles, shipping containers, pallets and other materials.

"We're urging ornamental growers, landscapers and forestry professionals to inspect incoming vehicles, equipment, and cargo—especially those moving between nurseries, planting sites, or forested areas—to help prevent further introduction and protect both cultivated and natural ecosystems," said Dave Coyle, Clemon Extension forestry specialist and associate professor of forest health and invasive species.

# CLEMSON INSTITUTE WORKS WITH INDUSTRY ON NEW MARKETS FOR SOUTH CAROLINA TIMBER

With South Carolina's forestry and forest products industries facing significant headwinds, Clemson University's Wood Utilization + Design Institute (WU+D) convened industry, government and academic leaders Sept. 24 at the Madren Conference Center to explore new products and markets for the state's abundant timber.

The meeting took place amid a series of high-profile mill closures, including those of International Paper in Georgetown, the WestRock plant in Charleston, International Paper in Savannah, and the Containerboard Mill in Riceboro, which have reduced market capacity and disrupted the wood supply chain.

"This has been a tough few years for forestry," said Guy Sabin, vice president of the Forestry Association of South Carolina. "It seems like in the past few years we've had decades of change. There have been changes in manufacturing, changes in demand. In fact, we've probably lost somewhere in the ballpark of 10 million tons of wood from our wood markets and productive capacity. It affects our entire wood supply chain."

South Carolina State Forester Scott Phillips said the losses impact all 46 counties.

"The loss of a paper mill is catastrophic, especially when you look at southern silviculture and how we grow trees in the South," Phillips said. "Losing the markets for small-diameter wood is devastating. Those paper mills are very high-paying jobs. In Georgetown, it was a loss of 750 jobs. The economic impact of that mill was right at \$1 billion. And then you have the impacts on the individual landowners and the entire forestry supply chain."

### RENEWED MISSION

WU+D was launched in 2013 to support the state's forestry industry by increasing the use of wood in sustainable and resilient building construction through cross-disciplinary collaboration among Clemson experts in forestry, architecture and construction science.

WU+D Director Soledad Peresin presented her plans for the future of the institute.

Since then, the institute has forged public-private partnerships, secured grants, designed and tested innovative wood-based building materials such as cross-laminated timber, and educated builders and architects nationwide on the environmental and construction benefits of wood.

At the open house, institute leaders highlighted a refreshed mission to drive innovation in wood and renewable bio-based materials through research, design and industry collaboration—aiming to make South Carolina "the Finland of the Southeast" in sustainable timber, bio-based products, and circular economy systems.

## WU+D EXPANDS ITS STRATEGIC PRIORITIES

M. Soledad Peresin, who was named to WU+D's Patricia "Pat" Layton Endowed Directorship in July 2025, described her role as the convergence of her passions for sustainable innovation, interdisciplinary collaboration, and industry engagement. She outlined strategic priorities for WU+D that include:

- Driving research and innovation in wood-based materials such as high-performance polymers, hybrid composites, coatings and adhesives
- Building strategic partnerships across academia, government and industry to accelerate innovation and commercialization
- Expanding stakeholder engagement and growing the institute's endowment to support research, infrastructure and outreach
- Investing in workforce development and experiential learning through hands-on student training and interdisciplinary collaboration
- Promoting a sustainable and inclusive bioeconomy by integrating life-cycle thinking into every facet of the institute's work

"WU+D is uniquely positioned at the intersection of research, material design and real-world application, an ecosystem I have thrived in throughout my career," Peresin said. "With Clemson's tremendous breadth of expertise, WU+D can build functional, market-ready solutions while cultivating the next generation of scientists and engineers. By marrying materials innovation, supply-chain development and education, WU+D can reconnect South Carolina's forests to a thriving market, revitalizing rural economies, landowner returns and the state's broader forestry sector."

Peresin earned her Licenciate (Masters') degree in Analytical Chemistry with a focus on Pulp and Paper Engineering from Universidad Nacional del Litoral in Argentina and her Ph.D. in Forest Biomaterials from North Carolina State University. She also spent six years as a senior scientist at VTT, the Technical Research Centre of Finland, where she advanced high-performance fiber-based products and the surface chemistry of lignocellulosic substrates in close collaboration with industry.

## TURNING CHALLENGES INTO OPPORTUNITIES

The open house showcased how WU+D and its partners hope to transform wood side-streams, which are by-products from pulp mills and sawmills once considered waste, into valuable materials such as lignin-based asphalt binders, advanced wood pulp adjuvants for agriculture, multifunctional bio-based coatings for mass timber and high-performance oriented strand board.

Clemson faculty are also expanding into intelligent packaging, water and air remediation and bio-based crop protection polymers by targeting \$4.4 million in federal funding.

The institute is collaborating with USDA, industry and multiple Clemson colleges on affordable housing, sustainable building materials and testing programs. Regional and global initiatives highlighted at the open house include the \$160 million NSF Regional Engine "BRIDGES" to make the Southeast a world leader in sustainable biobased manufacturing and ECO-LOOP, an international network enhancing circular economy opportunities for lignocellulosic products in 22 countries.

### LOOKING AHEAD

State forester Phillips praised WU+D for anticipating industry needs and convening partners to solve them.

"The WU+D Institute has been, from the very beginning, a forward-leaning organization that is very good at defining strategic issues that we're dealing with in the wood industry and then coalescing partners around those issues to create a path forward," he said. "Clemson University and WU+D have led the nation in bringing people together to talk about mass timber, and there's an opportunity for us here at Clemson going forward."

Peresin called on stakeholders to join her ambitious plan to diversify South Carolina's forest products industry.

"Clemson is a land-grant institution, and we owe it to our stakeholders to come up with solutions to help our struggling forest products industry," she said. "I have a plan, and it's very ambitious, and I need you all to start thinking about how you can play a role in this plan."

### SC STATE TO INTRODUCE THREE NEW AGRICULTURE DEGREES

\$15M NANCE HALL OVERHAUL WILL PROVIDE LAB SPACE FOR TWO NEW UNDERGRAD PROGRAMS, NEW MASTER'S DEGREE

ORANGEBURG, S.C. – The South Carolina State University Board of Trustees on Thursday approved three new agriculture degree programs designed to strengthen the university's academic offerings in the state's largest industry.

President Alexander Conyers said the new programs are directly tied to a \$15 million state-funded renovation of Nance Hall.

"The renovation of Nance Hall is critical as we launch our new agriculture degree programs in agricultural and natural resource management, animal and veterinary science, and natural resource management," he said. "The \$15 million provided by the state will allow us to create modern laboratories and teaching spaces that bring these programs to life.

"This investment ensures our students will have access to the advanced facilities they need to develop the skills that agriculture and related industries demand," Conyers said.

The new programs include two undergraduate degrees and a graduate degree:

- A Bachelor of Science in animal and veterinary science.
- A Bachelor of Science in natural resource management.
- A Master of Science in agricultural and natural resource management. The graduate program will have two options: one in animal science and one in natural resource management.

Dr. Ralph Noble, dean of SC State's College of Agriculture, Family and Consumer Sciences, said the programs are part of the return of agricultural studies to the university after more than 50 years.

"As you may know, agriculture was one of the initial academic programs at the school when it began back in 1896," Noble said. "But unfortunately, after 75 years in 1971, the program closed.

"Then in 2021, some 50 years later, we were fortunate enough to have the College of Agriculture, Family and Consumer Sciences come back and be visible in a state where agriculture is the No. 1 industry," he said.

Noble told trustees the new programs would prepare graduates for careers in food production, animal science, resource management, and related industries that face a shortage of trained professionals.

The new programs will complement SC State's bachelor's degree in agribusiness, which blends core business training with agricultural-sector coursework. Students gain hands-on and experiential learning opportunities, including internships and applied projects in farm, processing, or agribusiness settings.

"The approval of these new academic programs marks an exciting step forward for SC State University," said Dr. Frederick Evans, provost and vice president of academic affairs. "The B.S. in natural resource management, M.S. in agricultural and natural resource management, and B.S. in animal and veterinary sciences will provide our students with the knowledge and skills to tackle some of today's most pressing challenges in agriculture, sustainability, and animal health.

"These programs also strengthen our commitment to preparing graduates who are ready to lead in industries critical to South Carolina's economy and to the global community," Evans said.

Noble said graduates will be prepared for positions with agencies such as the U.S. Department of Agriculture, the South Carolina Department of Agriculture, agribusiness companies, public health organizations and graduate schools across the country.

## NATIONAL DEMAND FOR ANIMAL SCIENCE

Noble said the Bachelor of Science in Animal and Veterinary Science will align SC State with one of the fastest-growing agricultural fields nationwide.

"The animal and veterinary science degree program is one of the most popular ones in the country at all of the 100 or so land-grant universities," Noble said. "It is the most popular major in agriculture across the country, both at the 1890 institutions as well as majority schools."

He noted that the new program will also complement the creation of South Carolina's first veterinary school at Clemson University.

"Because we're trying to piggyback off this opportunity to join efforts with Clemson University's new veterinary school, we have met with them. We're starting some recruitment activities jointly with students who are currently here that may be residing in biology or in other areas on campus to help the profession," Noble said.

Noble explained that the animal and veterinary science program would include both a pre-veterinary option with rigorous science coursework and an animal industry option focused on agribusiness careers.

### A MODERN APPROACH TO NATURAL RESOURCE MANAGEMENT

The dean explained that natural resource management encompasses traditional agricultural disciplines.

"This degree program is a summation to some extent of soil science, plant science, water culture and agronomy, but it will include such things as controlled environment agriculture and vertical farming," Noble said. "Some of the new practices that we see taking place in urban areas — we think about things like food deserts — we have practices that will help address that."

He added that natural resource management also involves sustainable methods tied to food and environmental security, including the quality of water, air and soils — "the basis of what we grow for both food and animals ourselves.

### RESEARCH OPPORTUNITIES FOR UNDERGRADUATE AND GRADUATE STUDENTS

The programs will involve new faculty members with dual appointments in Academic Affairs and SC State Public Service and Agriculture's 1890 Research and Extension. Faculty members will be involved in agricultural technology – drones, robots and sensors – and sustainable, regenerative

and agricultural practices that focus on soil health skills required by various industries.

Students also will have access to research opportunities and practical experiences at SC State Public Service and Agriculture's Research and Demonstration Farm in Olar, South Carolina.

Noble emphasized that the new degrees would help connect SC State's students directly with faculty research, advancing the university's Carnegie R2 status as a high research activity institution.

"The graduate program is designed to support the R2 status and also to take advantage of 1890 Research and Extension for cutting-edge research currently being done," Noble said.

SC State Public Service and Agriculture's grantfunded programs in the developing West African nation of The Gambia provide a natural bridge to its new animal science degrees. Through partnerships focused on improving goat breeds and advancing livestock management, SC State faculty and students are helping address global nutrition and food security challenges.

These international projects give students hands-on experiences that complement their classroom studies, while reinforcing the global relevance of the new animal and veterinary science programs.

Trustees unanimously approved the new degrees. The programs are expected to begin enrolling students for Fall Semester 2026, pending approval by the South Carolina Commission on Higher Education.

"This is, I think, an exciting time to be at South Carolina State — an exciting time to be a part of the College of Agriculture, Family and Consumer Sciences, and I am looking forward to getting the programs started," Noble said.
