Authorized Farmer Participation Agreement

The Senior Farmers' Market Nutrition Program is a seasonal USDA food assistance program created by Congress in 2001 to provide participants with fresh, nutritious, unprocessed fruits and vegetables from local farmers' markets and increase awareness and use of community markets. In South Carolina, the Department of Agriculture (SCDA) and Department of Social Services (DSS) work in conjunction to provide participants who receive Senior Vouchers the opportunity to purchase South Carolina grown fruits, vegetables, and cooking herbs from local farmers' markets.

Authorized Farmer Participation Agreement

- I certify with my signature that I am a bona fide South Carolina farmer who plans to grow, harvest and market the fresh fruits, vegetables and cooking herbs listed on the attached crop plan at the farmers market listed.
- I certify that I will grow at least 50% of what I offer for sale to SCSFMNP participants.
- I have received and read the Senior Farmers' Market Nutrition Program Farmer Training Guide and understand that these rules and procedures are part of this Farmer Participation Agreement and that I agree to comply with them.
- I authorize SCDA and DSS to verify my bona fide status and/or crop plan by visiting my farm if needed.
- I agree to attend farmer training if I receive a program violation, and if I do not attend I will be disqualified from the program.
- I understand that violation of the rules and regulations as well as providing false information on this agreement may result in my suspension or disqualification in the Program.
- This agreement is not transferable. Any change of ownership or relocation of a farmer terminates this agreement, and the farmer's authorization to accept SFMNP checks is ended.
- A farmer may appeal an action of the SCDA denying its application to participate, imposing a sanction, or disqualifying it from participation in the SFMNP. Expiration of a contract or agreement shall not be subject to appeal. If you wish to appeal a decision, you may make a written request to the SC Department of Agriculture.
- Authorized farmers participating in the SFMNP shall not refuse to accept properly presented SFMNP checks in exchange for South Carolina grown fresh fruits, vegetables, or cooking herbs. Authorized farmers shall also establish and maintain non-discriminatory sales transaction procedures, including but not limited to acceptance of Senior Vouchers in the same manner as required of all customers using personal checks. Farmers must not discriminate against check recipients in price, quality, or service.
